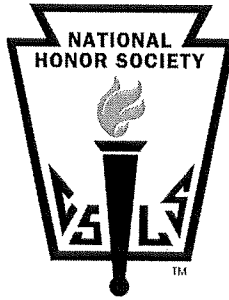


**NATIONAL HONOR SOCIETY  
AVONDALE CHAPTER  
AVONDALE HIGH SCHOOL**



**ARTICLE I: NAME AND PURPOSE**

Section 1. The name of this chapter shall be the Avondale Chapter of the National Honor Society of Avondale High School.

Section 2. The purpose of this chapter shall be to create an enthusiasm for scholarship, to stimulate a desire to render service, to promote worthy leadership, and to encourage the development of character in students of Avondale High School.

**ARTICLE II: MEMBERSHIP**

Section 1. Membership in this chapter shall be known as active, honorary, and graduate. Active members become graduate members at graduation. Graduate and honorary members have no vote in chapter affairs.

Section 2. Membership in this chapter is an honor bestowed upon deserving students by the faculty, and shall be based on the criteria of Scholarship, Service, Leadership, and Character.

Section 3. Eligibility:

- a. Candidates eligible for selection to this chapter must be members of the sophomore, junior, or senior class.
- b. To be eligible for selection to membership in this chapter, the candidate must have been in attendance for the equivalent of one semester at Avondale High School.
- c. Candidates eligible for selection to the chapter shall have a minimum cumulative grade point average of 3.5 on a 4.0 scale. This scholastic level of achievement shall remain fixed, and shall be the required minimum scholastic level of achievement for admission to candidacy. All students who can rise in scholarship to or above such standard may be admitted to *candidacy* for selection to membership.
- d. Upon meeting the grade level, attendance, and GPA standard requirements, candidates shall then be considered based on their service, leadership, and character.

## ARTICLE III: SELECTION OF MEMBERS

Section 1. The selection of members to this chapter shall be by a majority vote of the Faculty Council consisting of five faculty members appointed by the principal. The chapter adviser(s) shall be the sixth, non-voting, ex-officio member of the Faculty Council. Prior to notification of any candidates, the chapter adviser shall review with the principal the results of the Faculty Council's deliberations.

Section 2. Prior to selection, the following shall occur:

- a. Students' academic records shall be reviewed to determine scholastic eligibility.
- b. Students who are eligible scholastically ("candidates") shall be notified and asked to complete and submit the Candidate Packet for further consideration for selection.
- c. The faculty shall be requested to evaluate candidates determined to be scholastically eligible using the official evaluation form provided by the chapter adviser.
- d. The Faculty Council shall review the Candidate Packet, disciplinary records and faculty evaluations in order to determine membership.

Section 3. The selection of new, active members shall be held once a year during the first semester of the school year.

Section 4. Candidates become members when inducted at a special ceremony.

Section 5. Once selected and inducted, all members are expected to maintain the standards by which they were selected and maintain all obligations of membership as outlined in the Candidate Packet and Avondale Chapter of NHS Expectations of NHS Members.

Section 6. An active member of the National Honor Society who transfers from this school will be given a letter indicating the status of his/her membership and signed by the Principal.

Section 7. An active member of the National Honor Society who transfers to this school will be automatically accepted for membership in this chapter. The Faculty Council shall grant to the transferring member one semester to attain the membership requirements and, thereafter, this member must maintain those requirements for this chapter in order to retain his/her membership.

Section 8. During the Faculty Council's review of the Candidate Packets, all candidate names and identifying information are removed from the Candidate Packets in order to retain the anonymity of the selection process.

Section 9. Non-selected candidates have the right to appeal to the Appeals Review Committee. If appealing, the non-selected candidate must provide a written statement, within 10 days of their notification, explaining their case. The written statement must be typewritten, placed in a sealed envelope, and hand delivered to one of the NHS Advisors. The statement will be given to the Appeals Review Committee for further review. The decision of the Appeals Review Committee will be considered final.

## ARTICLE IV: DISCIPLINE and DISMISSAL

Section 1. Any member who falls below the standards of scholarship, leadership, character, or service may be dismissed from the Avondale chapter of the National Honor Society. A member of the National Honor Society is expected to maintain his/her academic standing and take an active role in service and leadership to his/her school and community.

Section 2. If a member's cumulative grade point average falls below the standard in effect when he/she was selected (3.500), he /she will be given a written warning and a time period for improvement. If the cumulative grade point average remains below standard at the end of the warning period, the student will be subject to further disciplinary action by the Faculty Council that may include dismissal from the chapter.

Section 3. If a member fails to perform any of the published obligations of membership, he or she will be given a written warning and a time period for improvement. If the obligation remains unmet at the end of the warning period, the student will be subject to further disciplinary action by the Faculty Council, which may include dismissal from the chapter.

Section 4. Violation of the law or school regulations can result in dismissal of a member. These violations include, but are not limited to, DWI, stealing, destruction of property, cheating, truancy, or possession, selling, or being under the influence of drugs or alcohol at school or school-related activities.

Section 5. Offenders of the school conduct code (such as use of profanity, failure to comply, unexcused absence, excessive tardiness, etc.) will receive a warning notification. A conference may be requested by either party (Faculty Council or student/parent). If the member is involved in another violation of the school conduct code, the member may be dismissed.

Section 6. In all cases of pending dismissal:

- a. The member will receive written notification indicating the reason for possible dismissal from the adviser/Faculty Council. The member and adviser(s) will discuss the written notification in a conference. Situations that involve flagrant violations of school rules or the law can warrant disciplinary action without a written warning although a hearing must still be held (see below).
- b. The member will be given the opportunity to respond to the charge against him/her at a hearing before the Faculty Council prior to the vote on dismissal. The member has the opportunity to present his/her defense either in person or in The Faculty Council will then vote on whether to dismiss. A majority vote of the Faculty Council is needed to dismiss any member.
- c. The results of the Faculty Council vote will be reviewed by the Appeals Review Committee, and then if confirmed, expressed in a letter sent to the student, parents, and principal. Dismissed members must surrender any membership emblems to the adviser.
- d. The Faculty Council's decision may be appealed to the Appeals Review Committee and afterwards through the school district discipline policy.
- e. When a student is dismissed or resigns, he/she is no longer a member and may never again be considered for membership in the National Honor Society.

Section 7. In lieu of dismissal, the Faculty Council may impose disciplinary sanctions upon a member as deemed appropriate.

## ARTICLE V: OFFICERS

Section 1. The officers of the chapter shall be president, vice president, secretary, treasurer, parliamentarian, and historian.

Section 2. Student officers shall be elected at the March or April meeting of each school year. All returning active members in good standing are eligible to run for a position as an officer. All active members of the chapter are eligible to vote. Officers who fail to fulfill their duties as determined by the chapter adviser(s) and the principal will be removed from their officer position and an election will be held to replace them.

Section 3. A majority vote shall be necessary to elect any officer of this chapter. If the first vote does not yield a majority, a second vote shall be taken of the two candidates receiving the highest number of votes.

Section 4. It shall be the duty of the president to preside at the meetings for this chapter and serve as the official representative of the chapter at school and community functions.

Section 5. The vice-president shall preside in the absence of the president and shall also keep a record of members' contributions to leadership and service.

Section 6. The secretary shall keep the minutes of meetings and be responsible for all official chapter correspondence.

Section 7. The treasurer shall keep the record of chapter expenses, dues, and all other financial transactions of the chapter.

Section 8. The Parliamentarian's responsibilities shall include but are not limited to declaring quorum at regular business meetings, maintaining and providing a record of attendance.

Section 9. The Historian's responsibilities shall include but are not limited to: maintaining and updating the bulletin board, creating a yearly slide show, and articles and newsletters.

Section 10. Upon the creation of a vacancy in the position of the President, the Vice President shall assume all responsibilities immediately. If both offices are vacated simultaneously, the adviser(s) shall open nominations for all vacant offices and use the same form of elections as prescribed in these bylaws.

## ARTICLE VI: EXECUTIVE COMMITTEE

Section 1. The executive committee shall consist of the faculty adviser(s) and the chapter officers.

Section 2. The executive committee shall have general charge of the meetings and the business of the chapter, but any action by the executive committee is subject to the review of the chapter members.

Section 3. The executive committee shall meet within one week prior to the regularly scheduled National Honor Society meeting and plan an agenda.

## ARTICLE VII: MEETINGS

Section 1. Meetings of this chapter shall be monthly. Unless other arrangements have been made, meetings shall be held prior to the start of the school day at 6:45 a.m. Meetings are generally scheduled for the second Tuesday of each month.

Section 2. All chapter members are expected to attend all regularly scheduled chapter meetings. Failure by a member to attend meetings may result in probation or dismissal.

## ARTICLE VIII: ACTIVITIES

Section 1. The chapter shall determine one or more service projects for each year.

Section 2. All members shall regularly participate in these projects.

Section 3. These projects shall have the following characteristics: fill a need within the school or community, have the support of the administration and the faculty, be appropriate and educationally defensible, and be well-planned, organized, and executed.

Section 4. Each member shall have the option to choose and participate in an individual service project which reflects his or her particular talents and interests as approved by the chapter adviser(s). This is in addition to the chapter projects to which all members contribute. Individual service requirements (inside/outside hours) will be outlined in the Avondale Chapter of NHS Expectations of NHS Members.

Section 5. The chapter shall publicize its projects in a positive manner.

## ARTICLE IX: ENBLEM

Section 1. Each member of this chapter who is in good standing with regard to the membership standards and member obligations shall have the privilege of wearing the emblem adopted by the National Honor Society

Section 2. Any member who withdraws, resigns, or is dismissed from the chapter shall return the emblem to the chapter.

Section 3. Chapter members who are seniors in good standing shall be granted the privilege of wearing the honor cords or other insignia adopted at the local level at graduation.

## ARTICLE X: DUES

Section 1. Annual dues for this chapter shall be \$15.

Section 2. Dues will be payable to the chapter treasurer or faculty adviser(s) within 30 days of induction. Students with financial hardships, or on free or reduced lunch may be waived of the due amount per approval of the principal.

## ARTICLE XI: POWERS

Section 1. The chapter adviser is given the authority to supervise the administration of chapter activities, as delegated by the school principal.

Section 2. The principal shall reserve the right to approve all activities and decisions of the chapter.

Section 3. These bylaws are designed to amplify provisions of the National Constitution and cannot contradict any components thereof. The chapter is obligated to adhere to the provisions of the National Constitution in all activities it undertakes.

## ARTICLE XII: AMENDMENTS

Section 1. These by-laws may be amended by a 2/3 vote of the chapter, provided notice of the proposed amendment has been given to members at least one month prior to the vote. The exceptions are Articles II, III and IV (selection and discipline), which are developed by the Faculty Council with the approval of the principal.

Section 2. Proposed by-law amendments may be proposed at any regular meeting of the National Honor Society. There shall be a discussion and vote on the proposed by-law amendment. If the amendments passes with a 2/3 vote of the chapter, the adviser(s) shall take the amendment to the Principal and Faculty Council for approval or revisions. If the Principal and Faculty Council approve the amendment, the membership shall vote on the amendment at the next regular meeting. If the Principal and Faculty Council provide revisions, the membership may vote on the revised amendment. The amendment passes with a 2/3 vote of the chapter after the Principal and Faculty Council review/approval.

Section 3. By-laws and amendments must be consistent with the Constitution of the National Honor Society.
